EACH SEASON, YOUNG PEOPLE COLLABORATE WITH PROFESSIONAL, WORKING ARTISTS - PLAYWRIGHTS, COMPOSERS, CHOREOGRAPHERS, ETC. - TO CREATE ORIGINAL PRODUCTIONS ADDRESSING ISSUES IMPORTANT TO THE YOUTH IN THE ENSEMBLE. THE PROGRAM HAS TWO COMPONENTS: MAINSTAGE BEGINS IN AUGUST AND CULMINATES WITH THE PRODUCTION IN DECEMBER OF AN ORIGINAL MAINSTAGE SHOW EXPLORING QUEER THEMES. THE TOUR - RUNNING FROM JANUARY THROUGH JUNE - FOCUSES ON ADULTS WHO WORK WITH YOUTH.
